



Tech Mahindra to Digitally Train Employees of U.S. Short Line Railroads to Increase Safety

Tech Mahindra will provide Positive Train Control (PTC) digital training customized for short line railroads

The online learning platform will include multiple modules of interactive training followed by assessment and evaluation. Each module will be completed within 120 minutes. The modules will cover the statute-required training for those short line and regional railroads that need to equip with PTC including train operations, dispatch, wayside, communications, and the interoperability between various PTC systems.

Chuck Baker, President, ASLRRA, said, "The implementation of PTC is a complex and costly project for the U.S. rail industry, including dozens of short line railroads. These small businesses have a complicated role to play, integrating with multiple Class I systems, and are challenged to implement with limited technical expertise and support. Tech Mahindra offers an easily accessible Web-based training program customized for short line railroads, giving our members confidence that they will be compliant with PTC training requirements."
